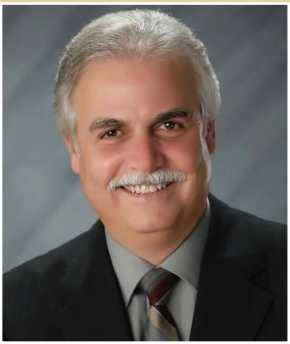

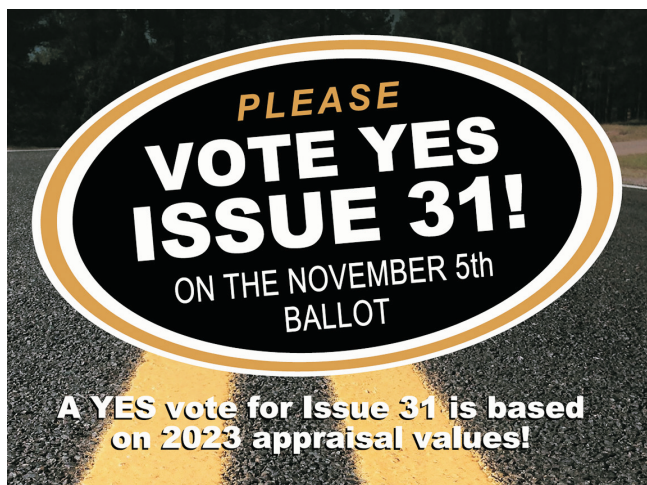

Critical Issues on the Ballot Next Month



On the ballot on November 5th for the Road Department is Issue 31. The passage of Issue 31 provides the funding to tackle our goal of paving 100 miles in the next 10 years. It also is our residents last chance to pass a levy on our old home values prior to the reassessment that was just completed. We need your support on issue 31 to accomplish our paving plan and stabilize our department. Currently, the Road Department operates on 3.0 total mills a 1 mill from 2014 and a 2 mill from 1986 which currently brings in \$1,221,755.

Issue 31 is a replacement levy of our current 2014 1 mill levy with a 2.9 additional for a total of 3.9 mills that is projected to bring in \$2,892,000 in revenue and if passed the 1986 2 mill levy would be allowed to expire.

Currently, the Road Department is only able to pave between 5 and 6 miles of Roads per year and that is declining every year. If Issue 31 fails at the ballot the Perry Township Road Department will lose funding from its 2014 levy and will only be able to pave between 1 and 2 miles of Roads per year. With almost 150 miles of roads to be taken care of, this situation will become critical.

If Issue 31 is passed, per \$100,000 in home value, the homeowner will pay \$137 per year or \$11.42 per month. This would be an increase of \$7.58 per month over what you would pay today on this home after the 1986 levy expires.

Passage of issue 31 will not only pave and repair our aging roads but stabilize our Road Department for years to come. Please join us at our meetings, on our Facebook page or at our community events to ask any questions or for more information.

On the November 5th ballot, your Fire Department will be asking for resident's support on Issue 32. Issue 32 is a replacement of our current levy from 2015.

With your support, the passage of this replacement levy will provide funding to assist us with:

- Maintaining staffing levels, enabling all of our stations to be open around the clock.
- Maintain and replace apparatus and equipment as necessary.
- Continue our fire prevention training programs.
- Improve and renovate our existing facilities.

The Perry Township Fire Department's main source of funding is our current 4.9 mills levy from 2015. This levy costs a homeowner approximately \$107 per \$100,000 of County-appraised home value.

The cost of the 4.9 mills replacement levy will cost a homeowner approximately \$172 per year per \$100,000 of County-appraised home value. This is an increase of \$65 per year or \$5.42 per month on this home of this value.

Strengthening Safety in Perry Township: STARCOM Enhances Local Dispatch Services

To enhance public safety and streamline emergency response services, the Stark County Sheriff's Office is proud to have the opportunity to collaborate to be the primary dispatch provider for the Perry Township Police and Fire Departments. On July 1st, Stark County Sheriff's Communication (STARCOM) officially assumed dispatching responsibilities for Perry Township's Police Department. Power Cot & Loader



In previous newsletters, we informed you about our ZOLL cardiac monitors and our ZOLL Autopulse, which are two important pieces of emergency equipment.

We now inform you about our power cots and loading system. This piece of equipment is necessary to get you to the hospital in a safe, secure, and comfortable manner. It also provides our crews with a safe, back-saving method of moving and transporting patients.

Although this equipment comes with a hefty price tag of approximately \$60,000 for both, it helps reduce the number of work-related and possibly career-ending injuries of our personnel.

The Cot:

- Able to navigate in tight quarters
- Perform a true, unassisted lift and reach optimal loading height using smarter hydraulic assembly with load-sensing capabilities
- Three-position foot section
- Multi-position upper torso segment for patient comfort
- Properly positioned patient safety belts
- Steer and wheel locks to aid in patient safety

The Loading System:

- Supports the cot throughout the loading and unloading process
- Eliminates the need to steer the cot into and out of the ambulance
- Helps minimize patient drops by supporting the cot until the wheels are on the ground

There is no comparison to the cots that were utilized when I first started to these modern, multifunction, ergonomic, injury-reducing, high-performance cots. They have a huge impact on our day-to-day operations by protecting our patients and our personnel. They have proven themselves time and time again.



A Few Fall Safety Tips

Safely warm up by the fire

Inspect your fireplace before lighting the first fire. One of the simple joys of autumn is warming up in front of a fireplace.

If you have a fireplace in your home, be sure to have it cleaned and inspected before lighting your first fire of the season. A buildup of soot and creosote can cause a chimney fire and a backup of dangerous carbon monoxide gas into your home. Keep the area around the fireplace clear and remove any hanging decorations from your mantle. Most importantly, always keep a fire extinguisher nearby.

Never leave burning candles unattended

While glowing candles make any environment feel cozier and smell fantastic, remember to keep burning candles away from anything that could burn, such as curtains, bedding, or books. Also, always extinguish a candle before going to bed or leaving the house. Never leave children or pets alone with a burning candle.

Watch for new roadway hazards

With school back in session, traffic challenges arise. School buses, pedestrians, students on bicycles, and teen drivers are out on the roads.

Slow down and take extra care to look for children in school zones, near playgrounds, and residential areas. Also, never pass a bus with flashing red lights on, or another vehicle stopped for a pedestrian.

Be alert for wildlife on roadways

Wildlife is on the move in the fall, so watch carefully for deer, turkeys, and other critters crossing the road in front of your vehicle. They are most active from dusk through dawn.

Remember that some animals – deer in particular – frequently travel in groups. If you see one crossing, more are bound to follow.

Share the road with harvesting equipment

In rural areas, fall brings the harvest season with large farming equipment on the roads. Be alert for slow-moving vehicles and give them plenty of space. This provides better visibility to you and the other driver. Remember that they may turn unexpectedly into fields or driveways. Just because you can see the equipment does not mean the other driver can see you.

Safely get the yard ready for winter

You've enjoyed your beautiful lawn and garden all summer, but now is the time to prepare it for a cold winter. Leaf blowers can be loud and blow more than just leaves, so wear eye and hearing protection to keep you safe from flying debris and preserve your hearing from the dangerous effects of repeated exposure to loud noises.

Practice ladder safety

Falling is one of the most common reasons for emergency room trips. If you plan to clean out your gutters, work as a team when using the ladder. Ladders can buckle or slip, so have someone hold the ladder as you use it.

Keep your body weight-centered over the ladder, and don't reach too far. It is better to move the ladder a few more times than fall.

Get your Flu/COVID/Pneumonia shots

Protect yourself from influenza with a flu shot. The viruses found in the influenza vaccine are inactive, so you cannot get the flu from the vaccine. After getting vaccinated, it takes about two weeks to develop antibodies to protect against influenza. That's why getting vaccinated early in the fall is recommended. The vaccine usually is available in early to mid-fall.

Lunch and Learn Program By George Davis

The Perry Township Police Department has increased its effort to protect residents from financial demise, crypto currency fraud and other scams by unscrupulous, unseen predators.

On Sept. 5, the department held its first-ever large scale *Lunch and Learn* program for over 100 Perry senior citizens, families and friends to better spread the word on how to recognize scams of all kinds and avoid falling prey to scammers.

These thieves use phones with untraceable numbers, computer messaging and cyber techniques to reach unsuspecting residents by going from friendly offers to threatening scare tactics to robbing victims' bank accounts and even life savings.

The free program was held at the McKinley Eagles Aerie 2370 on Monticello NW, where several large monitors showed video of a 46-page program presented by Perry Detective Danielle Paciorek and Jackson Twp. Police Detective Jeffrey Aynes, who focuses on financial cyber crimes.

Paper copies of the video were given to attendees for use at home when confronted by scammers, with instructions of how to be aware when the caller is providing false information to gain your favor.

Hosted by Perry Police and Perry Eagles, the luncheon was provided by Santangelo's Catering of Massillon and served by Perry Township department personnel and volunteers.

Several vendors provided mementos and answered questions of attendees on a wide range of topics, while CSE Federal Credit Union provided several Fall decorations as door prizes.

Detective Paciorek, in Stark County law enforcement over 10 years and at Perry since 2016, said the program goal is to provide residents with the knowledge and tools to recognize and prevent fraud. Paciorek and Aynes both stressed to be aware when answering the phone. Never provide any personal information and always contact authorities after hanging up.

I always look forward for the opportunity to talk about the SWCD and what we do. We're that small county agency that most people never really have much interaction with. Our agency currently falls under the umbrella of the Ohio Department of Agriculture and the Division of Soil and Water Conservation. This does not necessarily mean that our primary focus is on agricultural issues, even though a lot of our programs are related.

Our Mission: We are dedicated to conserving our natural resources by educating, guiding and assisting the citizens of Stark County.

Storm Water: Our storm water team works to ensure erosion and sediment controls are in place on active construction to protect soil and water resources. We evaluate and approve Storm Water Pollution and Prevention Plans for construction sites over one acre in size and inspect these sites to ensure they are using best management practices to control sediments and water on these sites. We currently inspect over 135 sites, county wide.

Drainage: Our drainage program provides technical guidance to landowners on how best to manage drainage issues on their property. This program covers all of Stark County.

Wildlife: We work with landowners to help promote healthy, diverse habitats for wildlife on their property. Our staff meet with landowners and can assist with a plan to create pollinator habitats, native prairies or managed woodlots.

Education: We offer workshops, presentations, fact sheets, and hands-on activities to help and protect our natural resources.

ZONING DEPARTMENT NEWS

Starting a new business in Perry Township, either by signing a lease to an existing business structure or constructing a brand new building is an exciting process for you as the business owner and promises to be a wonderful addition to the township.

If you are doing your startup with a new building you have several steps to complete – land surveys, plan reviews by multiple county agencies including township zoning, permits to obtain, and contractors to line up for the actual construction.

Moving into an existing building also involves several steps. All too often the new business owner and often the property owner who holds the lease may overlook several important requirements with local zoning and even the county building department which might lead to opening delays, unplanned expenses – even financial citations.

We want you to thrive in your business. Here are a few steps you need to take as you make your transition into the commercial segment of our community.

First, if looking at an existing building ask yourself if you wish to remodel the interior or exterior to better suit your needs. Exterior modifications which increase the size of a building will require a zoning certificate from the township and a building permit from the county. Although interior remodeling does not

require a zoning certificate you will need to contact the county for a permit.

Second, are you planning on adding signs to your space? Township has regulations defining the type, size, minimum and maximum height, number of permitted signs, and placement of signs for all businesses. Even replacing the face plate on an existing wall or pole sign or switching from a static to an electric (lighted) sign will require a zoning certificate. Be certain you contact the township and the county about these regulations.

Third, both new construction and existing structures must have a required fire safety inspection by the Perry Fire Dept. The inspector is looking for things like missing outlet covers, exposed wires, or missing exit signs. Were fire extinguishers left behind from the prior business owner? Be certain they are inspected and properly charged or need replaced. Your inspection must pass and a one time application for a Certificate of Conformance must also be completed BEFORE you open your doors for business.

Generally, the fire inspector will give you time to repair or replace any flagged items. Don't cut any corners! Keep yourself and your future clients safe from unforeseen issues or expenses down the road.

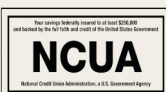
