Consider Vacation of Ortt St. SW

Consider Bank Reconciliation

Fiscal Officer Chessler referenced the bank reconciliations, supporting documents before the Board, that shows the checks that were issued and the checks that were made to the accounting system to reflect the balancing with our bank statement; also included is the final copy of the appropriations status report

as it shows the current funds available of each of the funds that we have at this time. Fiscal Officer Chessler stated that he is asking for a motion to accept and approve the bank reconciliations.

Trustee Haines made a motion that the Board receive and approve the bank reconciliations; Seconded by Trustee DeChiara.

Administration:

Consider Items for Govdeals On-line Auction

Administrator Fetzer referenced the Govdeals on-line auction items identified from each township department, supporting documents before the Board, and indicated that the Department Heads are seeking approval from the Board to place the proposed items on the digital auction site to properly dispose of the surplus, unneeded and obsolete property. Administrator Fetzer relayed that the appropriate ORC section 505.10 (D) public advertisement guidelines have already occurred.

Trustee DeChiara made a motion that per the recommendation of our Administrator, and the Department Heads that have submitted a list of items that are no longer usable for our needs in the township, that we put that list on Govdeals to auction off; Seconded by Trustee Shreffler.

Fire Department:

Consider Accepting FEMA Smoke Detector Grant

Chief Martin stated that the Fire Department is requesting that the Board of Trustees accept a FEMA Fire Prevention grant in the amount of \$58,000.00. Chief Martin referenced the supporting documents, attached before the Board, and indicated that this is a reimbursement style grant in which FEMA will reimburse us (95%) \$55,238.10 for the grant; we are responsible for (5%) \$52,761.90 of the grant.

Trustee DeChiara made a motion that the Township accept and approve the grant from FEMA for \$58,000.00, our 5% share will be \$2,761.90, for smoke detector installations; Seconded by Trustee Haines.

Consider Renewing Lexipol Subscription

Chief Martin stated that the Fire Department is requesting that the Board of Trustees renew the policy manual and training bulletins subscription with Lexipol at a cost of \$7,357.00; this is a one-year contract. Chief Martin relayed that once the subscription is renewed, the Township will be eligible for a \$1,000.00 reimbursement from Ohio Township Risk Management Authority.

Trustee Haines stated that based on that information, made a motion that the Board approve from Lexipol at a cost of \$7,357.00 for a one-year contract and based on that, we will get the \$1,000.00 reimbursement from OTARMA; Seconded by Trustee Shreffler.

Police Department:

Consider Massillon Cable Agreement

Chief Pomesky stated that the Police Department is requesting the Board of Trustees to authorize the renewal of the service agreement with Massillon Cable Television for three (3) more years of service (2020-2023). Chief Pomesky relayed that there is no price increase and we will continue to pay \$1,044.28 per month. Chief Pomesky also indicated that Massillon Cable will increase their bandwidth to 250/250Mbps with this agreement.

Trustee DeChiara stated that based on the information provided by Chief Pomesky, made the motion that the Board approve a three (3) year contract for \$1,044.28 per month to Massillon Cable Television
