Detailed discussion took place regarding the CARES Act expenditures among the Board, Fiscal Officer, Law Director and Administrator.

Trustee DeChiara stated that based on all of the conversation tonight made a motion that the Board approve purchasing CARES Act expenses for our Police, Fire, Road Department and Administration and that amount will be \$80,842.68. In addition, we are going to allot \$300,000.00 of our COVID money that has been distributed to Perry Township based on population to the businesses in Perry Township with the \$5,000.00 maximum per business, and with that, we are going to add \$75,000.00 of our allotted money from the government to individuals in the Township with \$1,000.00 maximum; we are going to add \$15,000.00 earmarked for the Perry Helping Perry Association for food and a tent purchase; and \$20,000.00 of our allocated money to 501(c)(3) organizations would be the Richville Park, Perry History

Club and any other said entities that come forward in the application with a \$1,000.00 maximum per subgrant and then we are going to have a \$40,000.00 allocation to the Perry school district, contingent upon need; all the remaining funds, unencumbered or unspoken for we are going to split 50/50 between the Perry Police Department and Perry Fire Department for salaries incurred between March 1, 2020 and December 30, 2020 due to the COVID situation; all funds have to be spent before December 7, 2020; Seconded by Trustee Shreffler.

Trustee Shreffler stated that we will add to the motion the term for applying for the grant is November 1, 2020 through November 15, 2020.
